



Election of Council – 2016-2018

In accordance with the M&A, the business of the Association shall be managed by the Council. The number of members of the Council shall be decided by the Annual General Meeting and shall not exceed 14 of whom 13 shall be elected from among the Corporate Members and 1 shall be co-opted by the Council under Article 3(c) hereof. A person is only eligible for election or re-election as a member of the Council if such person has been a Corporate Member or the then Ordinary Member prior to passing of the Special Resolution on 12 June 2014 for a continuous period of not less than 6 years prior to such election or re-election.

The Council shall comprise 14 members:

- Vice Chairman (1)
- Honorary Secretary (1)
- Honorary Treasurer (1)
- Council Members (10)
