**NOTICE** IS HERBY GIVEN THAT **an Extraordinary General meeting ("EGM")** of The Association of Registered Fire Service Contractors of Hong Kong Limited ("The Association") will be held **at Conference Room**, **Rm 1801, 18/F., Tung Wai Commercial Building, 109-111 Gloucester Road, Wanchai, Hong Kong** on Thursday, **12**<sup>th</sup> **June 2014 at 4:00pm** for the purpose of considering and, if thought fit, passing with or without modification or amendment the following resolution for the Amendment to Memorandum and Articles of "The Association".

## SPECIAL RESOLUTION

1. Deleting the definition of "**Member**" provided in Article 1 in its entirety and substituting the following new definition therefor:-

" "Member" means a member of the Association as registered and includes Members, Ordinary Members, Life Members, Honorary Members and Affiliate Members."

2. Deleting the definition of "**Voting Member**" provided in Article 1 in its entirety and substituting the following new definition therefor:-

" "Voting Member" means a Corporate Member or Life Member."

3. Deleting Article 2 in its entirety and substituting the following new Article therefor:-

"2. For the purpose of registration, the total number of Members is 900 (with the number of Corporate Members and Ordinary Members not to exceed 600), but the members of the Council may from time to time register an increase of Members. The subscribers and such other persons as the members of the Council shall admit to Membership shall be Members of the Association. Membership in the Association shall be classified as Corporate Members, Ordinary Members, Life Members, Honorary Members and Affiliate Members."

- 4. Deleting Article 3 in its entirety and substituting the following new Article therefor:-
  - "3. (a) Corporate Membership is open to fire service installation contractors having a place of business within Hong Kong and who are registered as Class 1 or Class 2 fire service installation contractors with the Fire Services Department for the time being of the Hong Kong Government as Registered Fire Service Installation Contractors.

(b) Ordinary Membership is open to fire service installation contractors having a place of business within Hong Kong and who are registered as Class 3 fire service installation contractors with the Fire Services Department for the time being of the Hong Kong Government as Registered Fire Service Installation Contractors.

(c) All Ordinary Members shall have the right to nominate one Corporate Member as Authorized Representative of the Ordinary Members. Such Authorized Representative shall be a Corporate Member who has been a Corporate Member or the then Ordinary Member prior to [date of passing the Special Resolution] for a continuous period of not less than 6 years at the time of such nomination. The Authorized Representative of the Ordinary Members shall be eligible as a member of the Council under Article 40 hereof."

- 5. Replacing the word "**Ordinary**" by the word "**Corporate**" in Article 4.
- Adding the words "Corporate Membership" before the words "Ordinary Membership" in the 1<sup>st</sup> sentence of Article 8 and adding the words "a Corporate Member," before the words "an Ordinary Member" in the last sentence of Article 8.
- 7. Replacing the word "**Ordinary**" by the word "**Corporate**" in Article 9.
- 8. Adding the word "Corporate" before the words "Ordinary, Affiliate" in Article 10.
- 9. Adding the words "**Corporate Members**," before the words "**Ordinary Members**" in Article 12.
- 10. Replacing the figure "**thirty**" by the figure "**five**" in the 1<sup>st</sup> sentence of Article 23.





- 11. Deleting Article 40 in its entirety and substituting the following new Article therefor:-
  - "40. The business of the Association shall be managed by the Council. The number of members of the Council shall be decided by the Annual General Meeting and shall not exceed 14 of whom 13 shall be elected from among the Corporate Members and 1 shall be co-opted by the Council under Article 3(c) hereof. A person is only eligible for election or re-election as a member of the Council if such person has been a Corporate Member or the then Ordinary Member prior to [date of passing the Special Resolution] for a continuous period of not less than 6 years prior to such election or re-election."
- 12. Replacing the words "Section 157E of the Ordinance" by the words "Section 168D of the Companies (Winding Up and Miscellaneous Provisions) Ordinance, Cap 32" in Article 49(a).
- 13. Replacing the words "Sections 131, 132, 140, 140A, 140B and 141 of the Ordinance" by the words "Sections 393 to 400, 402, 404 to 405, 408, 411 to 412, 416 to 422, 424, 426 to 428 and 575 of the Ordinance" in Article 63.
- 14. Replacing the words **"Section 358 of the Ordinance"** by the words **"Sections 902 to 904 of the Ordinance"** in Article 66.
